**RECYCLE** means to process old, used items in order that the material can be used to make new products. Examples of things that are often recycled are glass bottles and jars, plastic bottles, newspapers, aluminum cans and mixed papers.

**REDUCE** refers to lessening the amount of items or resources that are consumed, using only the amount that is needed, and looking for alternatives that will lessen our use.

**REUSE** means extending the 'life' or reusing an item rather than discarding or throwing it away.

**What is SINGLE STREAM RECYCLING?**

Single Stream Recycling reduces collection costs, permitting use of single-compartment trucks and automated handling of fewer, larger containers. Reduced sorting encourages residents' participation and may generate more materials. However, increased processing costs reduce the value of the collected materials and, without clear guidelines for those generating the recyclables, may increase contamination by unsuitable and food contaminated products (more residual waste created during processing). Please review the list of permitted recyclables to enter the single stream process. Workers for Millstone's Recycling Yard are going to be more vigilant with turning away non-recyclable items.

**MANDATED RECYCLABLES**



**Bottles & Cans**

**Aluminum Cans:** DO NOT INCLUDE FOIL, PIE TINS, TRAYS, COOKWARE

**Tin & Bi-Metal Cans Glass Bottles & Jars:**

DO NOT INCLUDE DISHWARE, LIGHT BULBS, CERAMICS, WINDOW GLASS, MIRRORS

**Plastic "Pourable Containers":** Neck of bottle smaller than body, #1 #2 ONLY Remove Caps.

Be careful to completely empty any container used for automotive fluids. Any leftover chemicals in containers can be disposed (call 732- 683-8686 for appointment) at the Household Hazardous Waste Facility.



**Newspapers**

**Newspapers and any inserts that come with the paper.** DO NOT INCLUDE ANY NEWSPAPER USED FOR PET WASTE OR HOUSEHOLD PROJECTS



**Corrugated Cardboard**

**Waffle section between layers.** DO NOT INCLUDE FOOD CONTAMINATED CARDBOARD (e.g. pizza boxes) OR WAXED CARDBOARD. Flatten boxes.



**Mixed Paper**

**Includes: letterhead, colored and white paper, junk mail, soft cover books, chipboard (e.g. ce-real boxes).** DO NOT INCLUDE FOOD WRAPPERS, PAPER CUPS OR PLATES OR ANY OTHER PRODUCT USED FOR FOOD OR PERSONAL HYGIENE. NO HARDCOVER BOOKS (UNLESS COVER & BINDER IS REMOVED)



**Leaves and Grass Clippings**

DO NOT DISPOSE WITH HOUSEHOLD TRASH. Grass clippings can be left on the lawn, added to compost piles, or brought to special drop-off at county landfill (for a fee).



**Car Batteries & Motor Oil**

Car batteries can be brought to a scrap yard. Motor Oil can be brought to Monmouth County Household Hazardous Waste Facility (call 732- 683-8686 for appointment) or local service stations. Most common household batteries (A, AA, AAA, C, D, 9 Volt) **can be disposed in regular trash.** However, rechargeable batteries should be brought to retail store drop offs (check www.rbrc for locations). Silver "button batteries" should be returned to municipal or county sponsored drop offs. Millstone Township's Municipal Building located at 470 Stage Coach Road has a receiving bin for "button batteries" only, NO OTHER BATTERY TYPES WILL BE ACCEPTED.



**Bulky Recyclables**

**Tree Parts** (limbs, branches, trunks) can be brought to the Municipal Brush pile during drop-off events. See Millstonenj.gov for dates. NOTE: Stumps, roots, vines and leaves are not accepted on site.



**Computers, Televisions, Printer and Electronics**

Free drop-off available at Monmouth County and on September 29, 2018 between 8:00 and 12:30 at 899 Perrineville Road.

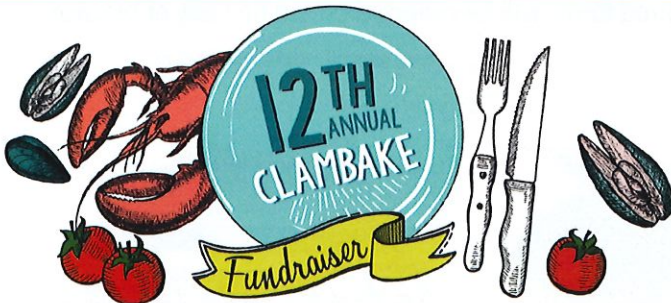

## HELPING YOUTH MANAGE LIFE TRANSITIONS

The term transition for the purpose of this article, is defined as the process of moving from one stage to another; moving from the known to the unknown. As our children experience the excitement of moving from elementary to middle school, or from middle to high school, they experience many changes, not only in their relationships, but also in their expectations. This can even apply to the yearly transitions from school back to families and neighborhoods during summer breaks.

When school lets out, any child not spending the summer in a full-time program, will have a lot of time on his hands. Youth old enough to be left home alone will lack supervision, kids with bicycles, cars, cell phones and computers have the ability to communicate with anyone and range far and wide in search of adventure—or illicit substances. Keeping young people safe this summer is a significant challenge parents may not be prepared for. Here's some advice on a number of things you can do to keep kids safe and drug-free this summer. Pick the ones you like best or try out all of them.

- Plan multiple activities as a family
- Set a good example of sobriety
- Talk to your kids about drug and alcohol use and be clear about your expectations.
- Talk about their response to peer pressure
- Talk, they hear you

# MONMOUTH COUNTY MOSQUITO CONTROL DIVISION

## Tick Identification

To combat the threat of tick-borne diseases to residents, the Tick-borne Diseases Program of the Monmouth County Mosquito Control Division provides the service of Tick Identification as part of an on-going research program for the residents of Monmouth County, who are eligible for this free service.




The best way to remove attached ticks is to grasp the tick with fine-tipped tweezers as close to the skin as possible; then pull straight up with a slow, steady force. Try to avoid crushing the tick or destroying it in any way. Clean the area of tick attachment with an antiseptic. Attached ticks should not be removed with noxious chemicals or by burning. This may cause injury to the skin and can increase the risk of transmission by causing the tick to regurgitate disease causing organisms into the body. Removed ticks can be saved in any sealed container to be later identified. Do not place ticks in tape! This makes subsequent identification difficult.

Ticks must be submitted in person at the Monmouth County Mosquito Control Division at 1901 Wayside Rd., Tinton Falls NJ 07724, between the hours of 8:15 a.m. and 4 p.m. only. You can submit them in any sealed container, such as a small Tupperware or Ziploc bag, and it does not matter if they are alive or dead. You will need to fill out a submission form with your contact information and details (to the best of your knowledge) about where the tick was found and how it was acquired. Ticks will not be processed without a signed submission form. Printed copies of the form are available when you bring in your tick.

The following information is given free of charge:

- **Tick species:** Different tick species can transmit different disease causing organisms, therefore knowing the species involved may alert you or your physician to watch for symptoms of specific disease(s).
- **Tick development stage & gender:** Different genders and stages of a tick (i.e., larva, nymph, adult) may be more or less likely to be infected with and/or transmit a disease-causing organism.
- **Tick engorgement level:** Engorgement level (how much blood it has taken in, i.e. whether flat, partially engorged, or fully engorged) is a relative indication of how long the tick was attached and feeding. The longer a tick is attached, the greater the risk that it may transmit a disease organism. For example, in the case of Lyme disease, at least 24 hours is usually required before the tick can effectively transmit the pathogen.

Only black-legged ticks ("deer ticks") can transmit the bacterium that causes Lyme disease. If your tick is identified as a black-legged tick, your risk of being exposed depends on several factors, including the life stage of the tick (nymphs and adult females are more likely to transmit), and how long the tick was attached (Lyme disease bacteria are more likely to be transmitted if the tick was feeding on you for 24+ hours, see above). However, regardless of tick ID results, if you develop any symptoms of Lyme disease you should see a physician. While Lyme disease is the most common vector-borne illness in Monmouth County, black-legged ticks can transmit other diseases, as can other species of ticks. See which ones in the table.

Results can provide information that may help you and your doctor in making diagnostic and treatment decisions. **HOWEVER, THEY CANNOT TELL YOU WHETHER YOU HAVE A DISEASE.** The identification and analysis of a submitted tick does not rule out the possibility that you may have had other undetected tick bites. Symptoms should never be ignored based on these results. *If you think you may have contracted a tick-borne disease contact your physician. He or she will be the most qualified to discuss diagnosis and treatment of tick-borne disease.*
