AMENDMENT TO ORDINANCE NO. 19-17 AMENDING CHAPTER II (ADMINISTRATION) PAYROLL OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF MILLSTONE BY FIXING SALARY RANGES OF THE TOWNSHIP OFFICIALS AND EMPLOYEES IN THE TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH, STATE OF NEW JERSEY.

WHEREAS, the Township Committee has determined that it is necessary to amend Ordinance 19-17, which established salaries and fixed compensation of certain Township Employees, to amend the salary range for the Construction Code Official.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Millstone, in the County of Monmouth, State of New Jersey, as follows:

SECTION I. The official designated below shall receive the amended annual salary range indicated, subject to the terms and conditions of employment for 2019 and 2020, in accordance with the CWA Contract term January 2019 through December 2022. (All additions are shown in **bold italics with underlines**. The deletions are shown as ~~**strikeovers in bold italics**~~.)

SECTION II. The remainder of Ordinance 19-17 concerning salary ranges of Township Officials and Employees shall remain unchanged.

SECTION III. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION IV. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION V. This Ordinance shall become effective upon final adoption and passage according to law.

This Ordinance was introduced on first reading at the Township Committee meeting on March 18, 2020, wherein a public hearing on the Ordinance will be held on April 1, 2020 at 8:00 p.m. at the Township of Millstone, Municipal Court, Meeting Room, located at 215 Millstone Road, Millstone Township, NJ 08535 or at any meeting to which that meeting may be adjourned, at which time all persons who may be interested therein will be given an opportunity to be heard.
