Motion to adopt, Moved C/Grbelja, Second M/Kinsey. Committee Discussion: Discussion takes place regarding the parking problems in various sections of the town. A starting point will be to restrict parking on certain sides of certain streets. It is also noted that the Code Enforcement officer cannot write tickets against title 39. Attorney Bob Munoz will review with Code Enforcement additional roads that can be added to Chapter 7 - traffic of the township code book. Discussion takes place regarding how we will move forward regarding mansion parties. C/Masci states he has reached out to Sheriff Golden. Attorney Bob Munoz if conference called in, he states he will write an opinion to send to the AOC regarding resolution 16-143. He will also be going to court and file a cease and desist since the residents at 40 Clarksburg Road are in violation of a Court Order. Bob Munoz also states that his office is doing all of the interviewing and investigating of these allegations, it may be time to hire a private investigator.
