Chapter V (Fees), Section 5-14 (Fees for Chapter XIV: Building and Housing), Subsection 5-14.3 State Uniform Construction Code Fees, Building and Housing is hereby amended as follows:

5-14.3a.–f. No change

5-14.3g. Fire Protection Subcode Fee. The fire protection subcode permit fee shall be as described below:

1. The fire protection permit fee for smoke, carbon monoxide and heat detectors shall be as follows:

Fire Alarm System \$250.00 From 1 to 10 devices \$50.00

Over 10 devices \$50.00 plus \$5 for each additional device
