AN ORDINANCE AMENDING CHAPTER 35 (LAND USE AND DEVELOPMENT REGULATIONS), ARTICLE 4 (REGULATIONS APPLICABLE TO ALL ZONING DISTRICTS) SECTION 35-4-14 (STORMWATER MANAGEMENT) OF THE REVISED ORDINANCES OF THE TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH, STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows (additions are **bold underlined**, deletions are **bold strikeouts**):

CHAPTER 35 (LAND USE AND DEVELOPMENT REGULATIONS) is hereby amended as follows:

Section 35-4-14.1 Scope and Purpose

 - 5. <u>Notwithstanding any rule to the contrary, a major development for any public</u> roadway or railroad project conducted by a public transportation entity that has determined a preferred alternative or reached an equivalent milestone before July 17, 2023, shall be subject to the stormwater management requirements in effect prior to July 17, 2023.

Section 35-4-14.2 Definitions

"Public roadway or railroad"

A pathway for use by motor vehicles or trains that is intended for public use and is constructed by, or on behalf of, a public transportation entity. A public roadway or railroad does not include a roadway or railroad constructed as part of a private development, regardless of whether the roadway or railroad is ultimately to be dedicated to and/or maintained by a governmental entity.

"Public transportation entity"

A Federal, State, county, or municipal government, an independent State authority, or a statutorily authorized public-private partnership program pursuant to P.L. 2018, c. 90 (N.J.S.A. 40A:11-52 et seq.), that performs a public roadway or railroad project that includes new construction, expansion, reconstruction, or improvement of a public roadway or railroad.

"State Development And Redevelopment Plan Metropolitan Planning Area (Pa1)"

An area delineated on the State Plan Policy Map and adopted by the State Planning Commission that is intended to be the focus for much of the State's future redevelopment and revitalization efforts.

"State Plan Policy Map"

<u>The geographic application of the State Development and Redevelopment Plan's goals</u> and statewide policies, and the official map of these goals and policies.

Note to Codifier: Existing definitions remain as is.

(b) Demonstrate through hydrologic and hydraulic analysis that the increase of stormwater runoff volume from pre-construction to post-construction for the **projected** 2-year storm, **as defined and determined pursuant to Section 35-4-14.5 D. of this ordinance**, is infiltrated.

4. The following types of stormwater shall not be recharged:

(a) Stormwater from areas of high pollutant loading. High pollutant loading areas are areas in industrial and commercial developments where solvents and/or petroleum products are loaded/unloaded, stored, or applied, areas where pesticides are loaded/unloaded or stored; areas where hazardous materials are expected to be present in greater than "reportable quantities" as defined by the United States Environmental Protection Agency (EPA) at 40 CFR 302.4; areas where recharge would be inconsistent with Department approved remedial action work plan <u>approved pursuant to the Administrative Requirements for the Remediation of Contaminated Sites rules,</u> N.J.A.C. 7:26C, or <u>Department</u> landfill closure plan; and areas with high risks for spills of toxic materials, such as gas stations and vehicle maintenance facilities; and

r. Stormwater runoff quantity standards.

 - (a) Demonstrate through hydrologic and hydraulic analysis that for stormwater leaving the site, post-construction runoff hydrographs for the <u>current and projected</u> 2-, 10-, and 100-year storm events, <u>as defined</u> <u>and determined in Section 35-4-14.5 C and D, respectively, of this</u> <u>ordinance,</u> do not exceed, at any point in time, the pre-construction runoff hydrographs for the same storm events;
 - (b) Demonstrate through hydrologic and hydraulic analysis that there is no increase, as compared to the pre-construction condition, in the peak runoff rates of stormwater leaving the site for the <u>current and projected</u> 2-, 10-, and 100-year storm events, <u>as defined and determined pursuant</u> to Section 35-4-14.5 C and D, respectively, of this ordinance, and that the increased volume or change in timing of stormwater runoff will not increase flood damage at or downstream of the site. This analysis shall include the analysis of impacts of existing land uses and projected land uses assuming full development under existing zoning and land use ordinances in the drainage area;
 - (c) Design stormwater management measures so that the postconstruction peak runoff rates for the <u>current and projected</u> 2-, 10-, and 100-year storm events, <u>as defined and determined in Section 35-4-14.5</u> <u>C and D, respectively, of this ordinance</u>, are 50, 75 and 80 percent, respectively, of the pre-construction peak runoff rates. The percentages apply only to the post-construction stormwater runoff that is attributable to the portion of the site on which the proposed development or project is to be constructed; or

35-4-14.5 Calculation of Stormwater Runoff and Groundwater Recharge

a. Stormwater runoff shall be calculated in accordance with the following:

1. The design engineer shall calculate runoff using **one of** the following methods:

(a) The USDA Natural Resources Conservation Service (NRCS) methodology, including the NRCS Runoff Equation and Dimensionless Unit Hydrograph, as described in Chapters 7, 9, 10, 15 and 16 *Part 630, Hydrology National Engineering Handbook*, incorporated herein by reference as amended and supplemented. This methodology is additionally described in *Technical Release 55 - Urban Hydrology for Small Watersheds* (TR-55), dated June 1986, incorporated herein by reference as amended and supplemented. Information regarding the methodology is available from the Natural Resources Conservation Service website at:

(b) The Rational Method for peak flow and the Modified Rational Method for hydrograph computations. The rational and modified rational methods are described in "Appendix A-9 Modified Rational Method" in the Standards for Soil Erosion and Sediment Control in New Jersey, January 2014. 2. For the purpose of calculating **runoff coefficients** <u>curve numbers</u> and groundwater recharge, there is a presumption that the pre-construction condition of a site or portion thereof is a wooded land use with good hydrologic condition. The term "**runoff coefficient** <u>curve number</u>" applies to both the NRCS methodology above at Section V.A.1.ii and the Rational and Modified Rational Methods at Section V.A.1.ii. A runoff coefficient <u>curve number</u> or a groundwater recharge land cover for an existing condition may be used on all or a portion of the site if the design engineer verifies that the hydrologic condition has existed on the site or portion of the site for at least five years without interruption prior to the time of application. If more than one land cover **have <u>has</u>** existed on the site during the five years immediately prior to the time of application, the land cover with the lowest runoff potential shall be used for the computations. In addition, there is the presumption that the site is in good hydrologic condition (if the land use type is pasture, lawn, or park), with good cover (if the land use type is woods), or with good hydrologic condition and conservation treatment (if the land use type is cultivation).

<u>c. The precipitation depths of the current two-, 10-, and 100-year storm events shall be</u> <u>determined by multiplying the values determined in accordance with items 1 and 2</u> <u>below:</u>

> 1. <u>The applicant shall utilize the National Oceanographic and Atmospheric</u> <u>Administration (NOAA), National Weather Service's Atlas 14 Point</u> <u>Precipitation Frequency Estimates: NJ, in accordance with the location(s)</u> <u>of the drainage area(s) of the site. 2. <u>The applicant shall utilize Table 5:</u> <u>Current Precipitation Adjustment</u> <u>Factors below, which sets forth the applicable multiplier for the drainage</u> <u>area(s) of the site, in accordance with the county or counties where the</u> <u>drainage area(s) of the site is located. Where the major development lies in</u> <u>more than one county, the precipitation values shall be adjusted according</u> <u>to the percentage of the drainage area in each county. Alternately, separate</u> <u>rainfall totals can be developed for each county using the values in the table</u> <u>below.</u>

d. <u>Table 6:</u> Future Precipitation Change Factors provided below sets forth the change factors to be used in determining the projected two-, 10-, and 100-year storm events for use in this chapter, which are organized alphabetically by county. The precipitation depth of the projected two-, 10-, and 100-year storm events of a site shall be determined by multiplying the precipitation depth of the two-, 10-, and 100-year storm events determined from the National Weather Service's Atlas 14 Point Precipitation Frequency Estimates pursuant to (c)1 above, by the change factor in the table below, in accordance with the county or counties where the drainage area(s) of the site is located. Where the major development and/or its drainage area lies in more than one county, the precipitation values shall be adjusted according to the percentage of the drainage area in each county. Alternately, separate rainfall totals can be developed for each county using the values in the table below.

Section 35-4-14.8 Safety Standards for Stormwater Management Basins

a. No change.

b. The provisions of this section are not intended to preempt more stringent municipal or county safety requirements for new or existing stormwater management basins <u>and/or</u> <u>BMPs</u>. Municipal and county stormwater management plans and ordinances may, pursuant to their authority, require existing stormwater management basins <u>and/or BMPs</u> to be retrofitted to meet one or more of the safety standards in Section 35-4-14.8c1, 2 and 3 for trash racks, overflow grates, and escape provisions at outlet structures.

c. Requirements for trash racks, overflow grates and escape provisions.

 - (b) The overflow grate spacing shall be no less greater than two inches across the smallest dimension.
 - (c) No change.
- 3. Stormwater management basins shall include escape provisions as follows:

(a) If a stormwater management basin <u>and/or BMP</u> has an outlet structure, escape provisions shall be incorporated in or on the structure. Escape provisions include the installation of permanent ladders, steps, rungs, or other features that provide easily accessible means of egress from stormwater management basins <u>and/or</u> <u>BMP</u>. With the prior approval of the municipality pursuant to § 35-4-14.8c, a freestanding outlet structure may be exempted from this requirement;

(b) Safety ledges shall be constructed on the slopes of all new stormwater management basins <u>and/or BMP</u> having a permanent pool of water deeper than 2 1/2 feet. Safety ledges shall be comprised of two steps. Each step shall be four feet to six feet in width. One step shall be located approximately 2 1/2 feet below the permanent water surface, and the second step shall be located one to 1 1/2 feet above the permanent water surface. See § 35-4-14.8e for an illustration of safety ledges in a stormwater management basin <u>and/or BMP</u>; and

(c) In new stormwater management basins <u>and/or BMP</u>, the maximum interior slope for an earthen dam, embankment, or berm shall not be steeper than three horizontal to one vertical.
