AN ORDINANCE AMENDING CHAPTER 5 FEES, SECTION 5-14 (FEES FOR CHAPTER 14: BUILDING AND HOUSING), SUBSECTION 5-14.3 (STATE UNIFORM CONSTRUCTION CODE FEES. BUILDING AND HOUSING), OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows: (additions are <u>underlined</u>, and deletions are in [brackets]).

Chapter 5 (Fees), Section 5-14 (Fees for Chapter 14: Building and Housing), Subsection 5-14.3 (State Uniform Construction Code Fees. Building and Housing) is hereby amended as follows:

- 5-14.3a.–e3. No change.
- 5-14.3.e4. The building permit fee for renovations, alterations and repairs shall be computed on the estimated cost of construction as follows:
 - (a) 0.[035] 040 per cost of construction.
- 5-14.3.e5. No change.
- 5-14.3.e6. The building permit fee for swimming pools shall be as follows:
 - (a) \$[75] 80 for residential above ground pools; portable spas and hot tubs.
 - (b) $\left[\frac{200}{225}\right]$ for residential in ground pools.
 - (c) [300] 375 for public pools.
- 5-14.3.e7. The building permit fee for "U use group" for a shed and pole barn shall be \$0.030 per cubic foot of volume, <u>detached garages shall be \$0.035 per cubic foot of volume</u>, all other U use by cost.

- 5-14.3.f. Electrical Subcode Fee as per State. The electrical subcode permit fee shall be as described below:
 - 1. The electrical permit fee for receptacles, switches and fixtures and equipment less than 1 hp and 1 kW shall be as follows:
