# **TOWNSHIP OF MILLSTONE PLANNING BOARD NOTICE OF HEARING**

PLEASE TAKE NOTICE that, pursuant to N.J.S.A. 40:55D-13 of the Municipal Land Use Law (the "MLUL"), the Township of Millstone Planning Board will hold a Special Meeting to conduct a public hearing virtually via the Zoom conferencing platform at 10:30 a.m. on June 24, 2025 to hear public comment on the adoption of the Township's Housing Element and Fair Share Plan ("HEFSP" or "Plan"), which will amend the Township's Master Plan. After public comment, the Planning Board shall consider adoption of the Plan by way of resolution.

The proposed HEFSP was prepared in accordance with N.J.S.A. 40:55D-28(b)(3) of the MLUL and the mandatory requirements of a Housing Element under the recently amended New Jersey Fair Housing Act (P.L. 2024, c.2), relevant regulations of the New Jersey Council On Affordable Housing ("COAH"), and other applicable law. For ease in reference, the FHA as amended shall be referred to as "FHA II" in this resolution. The HEFSP also delineates the actions taken, and to be taken, by the Township to satisfy its affordable housing responsibilities under applicable laws.

The HEFSP, an element of the Township's Master Plan, describes how the Township will meet its affordable housing obligation through various compliance mechanisms. The Township's was determined by the New Jersey Department of Community Affairs to have a present need or rehabilitation component of seven (7) affordable units and a prospective need or new construction obligation of ninety-eight (98) units for the period of 2025 to 2035.

A copy of the proposed HEFSP of the Township's Master Plan, and any other relevant documents, are on file for public inspection starting on June 13, 2025 and available Monday through Friday in the Municipal Building, 470 Stage Coach Rd. Millstone, New Jersey 08510 during regular business hours and will be available on the Millstone Township Planning Board website by clicking "Documents" for the meeting: https://www.millstonenj.gov/pb-agendas-minutes. Any party interested in commenting on the Fourth Round HEFSP may do so at the public hearing or may submit written comments to the Planning Board prior to the public hearing date. Formal action may be taken.
