Ms. Gentz - President of A&M Redbirds football. We are looking to bring the idea of a one-day football camp to Millstone.

Mr. Caputo – Son has been part of A&M (Redbird's football) and I have coached since he was five. Pleasure of meeting Nick (Shafnisky) last summer at an AMPT camp in another town. Have camps that include NFL players. Event brings community together and teach skills like leadership, motivation, and sport. Want to bring an event like this to Millstone, it would be great for the town, football program, and sports programs in general. Looking to use Millstone Park.

Mr. Shafnisky – Former college football player. Grew up with Saquan Barkley (Current Philadelphia Eagles running back) and assisted in getting AMPT started. Has connections with NY Jets and NY Giants players, however also with other pro athletes.

Ms. Gentz – A&M Redbirds would want a tent to sell concessions and hopefully get new people registered.

C/ Adornetti – Would this event be run through RedBirds football?

Ms. Gentz – We want to be affiliated with it. It will be advertised as an AMPT event.

C/ Kilcomons – Would be nice to have an event like this. Would there be a cap?

Mr. Shafnisky- We would cap at 150 to keep kids moving. Would want to offer different packages.

C/Randazzo – What about hosting event at Wagner Farm Park. They have stands and could use the concession stand. Could also park across the street from Park.

C/Adornetti – If you are interested in a meet and greet situation we could use the inside of the building also.
