# **LIAISON REPORTS:**

DM/Morris announced that Millstone Day is scheduled for Sunday, September 8<sup>th</sup> from 12pm – 5pm at Millstone Park, 4 Red Valley Road. There will be live bands, inflatables, food trucks, amusement rides and over 40 local businesses and clubs. Also, there will be a display of historic artifacts from the Baird Homestead. There is a lot of time and effort that goes into this event. Please come out and enjoy the day.

C/Zabrosky said the Girl Scouts held a Summer Luau Party for the Seniors last Tuesday. It was a lot of fun and thanked the Girl Scouts for volunteering their time and supplying the food and decorations.

M/Ferro stated that the Fire/EMS responded to 104 calls for the month of July which included 72 medical calls, 17 motor vehicle accidents, 15 fire calls and 71 transports to various hospitals. The day shift had 62 calls; night shift had 42 calls with 17 calls for mutual aid.

M/Ferro read the following announcement from the Millstone Township Fire District:

On August 13<sup>th</sup> 2024 the Millstone Township Fire District placed into service Ambulance 3259. Ambulance 3259 is a 2023 Ford E450/SIV remount. The original ambulance box was manufactured by Horton. This ambulance is licensed by the NJ Office of Emergency Medical Services which operates under the State Department of Health. This ambulance is equipped with a Stryker Power Pro 2, powered stretcher. This battery-operated stretcher comes complete with a self-loading system for the stretcher, with the ability to lift up to 700 lbs. This state-of-the-art equipment will prevent lifting injuries to patient care providers. This vehicle purchase was made possible through careful fiscal management, under the shared service program with Millstone Township and revenue generated by billing for EMS services.

Within 1 hour of being placed into service, this ambulance answered its first incident, a second simultaneous EMS call. Within its first 24 hours of service, it responded to 10 different incidents and transported 6 patients.

The Millstone Township Fire District now has 3 fully equipped ambulances in its fleet. This vehicle gives the department the ability to always guarantee two ambulances to the community, allowing for a vehicle to be out of service for repair or maintenance as well as positioning the department to engage in a future remount program. This type of program will allow for the existing ambulance box to be refurbished and mounted on a new chassis, which represents a significant cost savings versus purchasing a new vehicle.

M/Ferro stated that the Fire/EMS are doing a phenomenal job and from the residents they are second to none and thanked the Fire/EMS for all they do. C/Zabrosky stated that she saw the new ambulance and it is state of the art.

He questioned why he had to pay \$50 for a tree permit when the tree he removed was dead with a life threating situation. M/Ferro stated that the ordinance does waive fees for dead trees but you need to submit documentation from a Licensed Tree Expert. Mr. Recalde will submit the documentation. Second, he expressed concerns regarding the parks. Millstone Park needs benches at the Tennis Courts on the outside of the courts not inside the courts. The tennis courts are cracking at both Millstone and Abate Parks, especially Abate Park. Third, Millstone Park needs some type of a shade cover over the children's playground as the playground equipment gets very hot.

Richard Oberlander, 579 Stagecoach Road, Allentown, NJ is a certified arborist, tree surgeon, landscaper and exterminator. He discussed his concerns regarding the Township ordinance that states you can't put out lawn signs. He feels it is unconstitutional. He puts the lawn signs out and Code Enforcement removes them. He puts his signs out in other towns and they don't touch them. The Township Attorney will review the sign ordinance and will discuss with the Township Administrator.
