### LIAISON REPORTS:

C/Zabrosky stated that she spoke with school transportation regarding the passing of school buses. Since September, 19 cars have been caught passing school buses and she would like to also include community service along with the fines. Trooper Solano, NJSP and the School Resource Officer for Millstone, spoke and stated that out of the 19 cars, 11 tickets have been issued. Every person who receives a ticket needs to appear in Court as it is a 5-point violation. Trooper Solano is working, along with Millstone Township and the schools, to make everyone aware that you need to stop for school buses, what the violations are and that the law is being enforced. Two large traffic alert signs, which are placed on Millstone Road, state that you need to stop for every school bus, there is a 5-point violation and zero tolerance. The Township Administrator stated that the signs were lent to us by Monmouth County. Trooper Solano stated that the signs are great and suggested that the use of social media would also be very helpful in getting the word out. Karino Ramos, 166 Millstone Road and a Board of Education member, asked if the Trooper noticed a pattern and where are these signs located. Trooper Solano stated that a lot of the violations are happening on Millstone Road and Trenton-Lakewood Road and that is where the signs are located. M/Ferro and Ms. Ramos would like Trooper Solano to attend the December 16, 2024 Board of Education meeting to help with getting the message out. Trooper Solano agrees to attend and will come out with an official statement that can be posted on the official websites of both the Township and School. Trooper Solano stated that all of the troopers have been made aware of this situation. M/Ferro thanked the NJ State Police for all of their assistance.

C/Davis stated that the Shade Tree Commission has an opening and if you are interested in volunteering, please complete a Talent Bank application and forward to the Municipal Clerk. The form is on the Township website <a href="https://www.millstonenj.gov">www.millstonenj.gov</a>.

DM/Morris stated that Millstone Recreation is accepting new unwrapped toys for children ages 2 to 15 and will be collecting through December 13<sup>th</sup>. Donations can be dropped off at the Millstone Municipal Building. All toy donations will be distributed to local area children. Millstone Winter Wonderland will be held on Friday, December 6<sup>th</sup> from 5-9pm at Millstone Park. There will be live holiday music, food trucks, Christmas tree lighting, pictures with Santa, crafts and inflatables for the kids and much more.

M/Ferro stated that the Fire/EMS responded to 84 calls for the month of November which included 49 medical calls, 16 motor vehicle accidents, 19 fire calls and 55 transports to various hospitals. The day shift had 47 calls; night shift had 37 calls with 15 calls for mutual aid. M/Ferro thanked the Fire Department for all they do.

## **NEW BUSINESS:**

1. The Township Administrator stated that the tax assessment cards were mailed out and the average home increased about 16% but that doesn't mean your taxes will go up that much. Home property inspections will begin next year with RDS. Additional information will be sent out.

## **OLD BUSINESS:**

1. Buck Mine – Status Update: William Stone stated that a meeting with Monmouth County will be held on Wednesday, December 11<sup>th</sup> at 10am in the Administrator's Office to discuss what the next logical steps are. M/Ferro stated that the Township Committee members each drove down the road and it is not in the best shape, but we don't want you to do the job twice. You are still operational and have a few hundred cubic feet of dirt to remove by June with trucks still driving on the road. The Township Committee will extend the deadline to pave the road to June 30, 2025, under certain conditions, such as if potholes develop or the road caves in you will need to address the issue immediately and continue to keep the road maintained. When the permit expires on June 30, 2025, you will be closing the mine and it is expected that the road will be repaved. The Township Committee request a status update at the Township Committee meeting on April 2, 2025.

The Township Attorney stated that a motion needs to be made to approve the relief from the condition set forth in Resolution 24-177, which required that Buck Mining resurface and mill the haul route as required, located on Pine Hill Road, by November 15, 2024. That is, Buck Mining is granted an extension of time to resurface and mill the aforesaid haul route as required no later than June 30, 2025, with certain conditions and to appear at the April 2, 2025 Township Committee Meeting with a status update.
